Rebecca Evarts - Yarmouth, ME & Barcelona, Spain



After graduating from Harvard in 1974, I worked as an editor in New York publishing houses. I moved to Barcelona in 1985 with my husband and our first child, where we lived for the next seven years. I have worked as a freelance writer, and in 2002, received an MFA degree from Bennington College. We now live Yarmouth, Maine, and spend half the year in Barcelona.

My involvement with Safe Passage began in 2006 when I first went to Guatemala as a Spanish interpreter for a group of Maine surgeons and it occurred to me to write an article about Hanley Denning for a Maine publication. During that trip, I spent a day with her at the Project and came away both amazed by her and by what she was doing. After the tragedy, I became the sponsor of a two-year-old child, Linda Rosmery Ayapan Sánchez, whose mother was one of Hanley's earliest students. I've been back to Guatemala almost every year since which has allowed me to get to know our sponsored child, as well as her mother and little brother. I am also sponsoring Linda Rosmery's little brother, John Paul Ayapan Sánchez, who has just entered the third grade in the Hanley Denning School. We always take an excursion together that gives us time to talk. Since 2012, my husband and I have been working as interpreters for Shared Beat, the group of doctors who conduct twice-yearly physicals of Safe Passage students. This is has given me an opportunity to see a broad spectrum of students as well as to observe the evolution of the Project.

She is active as a facilitator with Rotary International, working with local clubs and districts. She is a frequent motivational speaker at regional and international events. Carolyn is Vice-chair of the Literacy Rotary Action Group, an advisor to the Rotary Foundation's Water, Sanitation & Hygiene In Schools programs, and serves as a consultant and project reviewer for major Rotary Foundation education & literacy grants. Carolyn was awarded the Service Above Self Award, Rotary's highest award recognizing Rotarians who demonstrate their commitment to others through volunteering their time and talents.

Carolyn has been involved with a number of community organizations, including Yarmouth Senior Housing, which provides safe, affordable housing options for older citizens.
