OUR HISTORY:

Safe Passage was founded on the principle that every child possesses
dignity and the right to define their own future. It started in 1999
when educator and social worker Hanley Denning visited the garbage dump
in Guatemala City and felt called to act after witnessing the harsh
realities faced by families living in the area. Local leaders worked
side by side with Hanley to recruit and maintain children in the
program, build community trust, and lay the foundation for a safe and
supportive learning environment.

Today, Safe Passage supports 530 students and affiliates each year,
representing 350 families and more than 3,000 individuals in Zones 3 &
7 of Guatemala City, an area with about 60,000 total residents who face
extreme poverty, food insecurity, limited access to quality education,
and violence. In response to this reality, our model addresses the
systemic barriers of abject poverty and economic exploitation through
holistic, trauma-informed education and wellness services, including
nutrition, mental health, and family engagement, keeping students in
school and fostering long-term opportunities. Through our Expeditionary
Learning model, students engage in a trauma-informed, interdisciplinary
approach where they learn by doing connecting academic content to their
environment and experiences while strengthening critical thinking,
collaboration, and resilience.

After 26 years of evolving and implementing our model in the community,
our alumni demonstrate high levels of academic achievement,
employability, leadership, and community engagement.

EARLY CHILDHOOD The early childhood program offers a unique curriculum for children aged 3-6, incorporating mindfulness and emotional health through play and discovery, while fostering self-esteem and laying the groundwork for educational foundations.

El COLEGIO - The elementary school serves grades 1-6 based on project-based Expeditionary Learning (EL). "Expeditions" are 6 to 12 weeks long, collaborative, interdisciplinary research projects that help students apply knowledge to real-world scenarios in a culturally and linguistically appropriate manner.

BASICO - Basico serves middle school students in grades 7-9. Curriculum takes the next step in EL, engaging students in in-depth projects that apply knowledge directly to relevant, real-world scenarios. Basico couples this curriculum with socio-emotional learning and presentation skills, empowering students to be strong agents of change in their own future.

OPORTUNIDADES & PRXIMO PASO - Safe Passage continues to support 9th-grade graduates as they attend external high schools and provides half-day supplemental education in computer technology and bilingual proficiency, along with internships, university, and career preparation. They continue to have access to mental health services and family social workers.

INTEGRATED HEALTH AND SOCIAL SERVICES - Safe Passage cares for the well-being of students through its integrative health services, which include a nutrition program that provides four healthy meals and daily snacks, SRH education, socio-emotional and ethical learning throughout our programs, health education, an on-site clinic, social services, and a robust psychology department.

PROGRAM PARTICIPATION: In 2025, our educational program supported nearly 530 students, ranging from preschool to high school. Safe Passage also provides various services to other family members (over 350 families). At the community level, family engagement sessions and student expedition presentations ensure that what students learn through expeditions and special activities is shared with the broader community.

LOCATION: Program facilities are located on four sites in the community surrounding the municipal garbage dump, between zones 3 and 7, in Guatemala City. These sites include the early childhood education center and preschool, with a kitchen and athletic facilities (for students ages 3 to 6). The primary school and middle school (full-day grades 1 to 6, plus a library, kitchen, and playground). A new Basico - Middle School Facility completed in 2025 will open in 2026 to 120 middle schoolers (for students grades 7-9), it includes STEM, Computer, Art and Music Labs, and a full rooftop gymnasium. Safe Passage houses its health clinic and administrative offices at the Middle School location. "El Centro", located adjacent to the entrance of the dump, is home to the high school programs, Oportunidades & Proximo Pasos. Safe Passage currently rents space to a partner organization, Creamos, which shares land with El Centro and offers complimentary adult and family programs to amplify intergenerational community impact Safe Passage

also has a small team of U.S.-based staff working in finance, fundraising, and communications, each of whom works remotely.

STAFF: In 2025, 120 staff were employed by Camino Seguro and Safe Passage. The majority of staff are Guatemalan and lead and carry out the day-to-day operations of Camino Seguro. The U.S. office underwent restructuring in 2024 and transitioned to a more remote and nimble model. In 2025 there were two full-time and one part-time employees in the U.S. and a part-time contracted agency that supports communications. We also receive national and international volunteers to support our mission in Guatemala.

2025 PROGRAM ACCOMPLISHMENTS:

OPORTUNIDADES & PRXIMO PASOS - In 2025, Oportunidades continued to expand and enhance our programs serving young people ages 14 to 21 through academic support, vocational guidance, leadership training, and career and job readiness. 33 Safe Passage affiliates were enrolled in university programs, and many others participated in hands-on learning focused on problem-solving, computational thinking, and English skills development. With new strategic partnerships and plans for additional coaching, services, and scholarships, we are supporting the dreams and pathways that our students are leading forth.

NUTRITION, MEDICINE, AND COUNSELING:

Our integrated wellness model reached further than ever in 2025. The clinic served 4,813 patients; our team exchanged nearly 270,000 calls and messages with families throughout the year; and 2,321 psychometric and psychological assessments were administered. Forty-eight families participated in the "Nurturing with Love" parenting program. Together with our partner Shared Beat, who brings expertise in community health, we continue weaving preventative health education and social-emotional learning into every corner of campus life ensuring that academic progress and personal wellbeing grow side by side. In 2025 we teamed with Moore Medical to broaden care to community members. Through a partnership with Guatemala Youth Initiative, Safe Passage deepened and expanded Sexual and Reproductive Health (SRH) education and services in 2025an essential component of our holistic modelso that students from middle school through early adulthood can navigate adolescence and young adulthood with confidence, accurate information, and supportive networks. In 2025, our students and affiliates experienced zero pregnancies, down from an average of 15-18 10 years ago.

ENGLISH-LANGUAGE INSTRUCTION AT ALL LEVELS: Recognizing the advantages that English-language speakers have in the job market in Guatemala, Safe Passage provides English language instruction from age 3 through high school, using interactive methods consistent with Safe Passage's educational pedagogy. In 2025 Safe Passage partnered with Duolingo to formalize English certification processes for our older students, providing them with a credible certification level for their job-seeking and higher education pathways Additionally in 2025, Safe Passage launched its first English Festival, a week-long celebration of learning through themed activities that engage students, teachers, and staff through language.

fabric of our educational model a space to experiment, reflect, heal, and express. Safe Passage hosted its inaugural Festival de Arte "Creciendo Juntos: 25 aos de transformacin y esperanza." Over four days, students across all grade levels participated in artistic workshops led by teachers and guest artists. From our Early Childhood through highest grades students explored music, visual art, and movement. The festival culminated in student exhibitions showcasing the remarkable range of creative work produced throughout the week. Beyond the yearly festival, arts programming is integrated into our educational curriculum.

NEW MIDDLE SCHOOL BUILDING AND COMPLEX (BASICO): After seven years of planning, fundraising, and dreaming, Safe Passage inaugurated its new Middle School building in the Fall of 2025 a \$1 million milestone made possible by an extraordinary community. The space offers more than 120 students dedicated classrooms, a gymnasium and sports courts, and arts, music, and STEM areas. For the first time, middle schoolers have an age-appropriate home designed specifically for how they learn, create, and grow. The middle school officially opens for students in July 2026.
